Pulizia e manutenzione – Per la manutenzione del tessuto spalmato consigliamo di passare con frequenza almeno mensile la superficie, utilizzando un aspirapolvere. In caso di unto, utilizzare solamente un panno leggermente umido e sapone neutro, non strofinare e lasciare asciugare naturalmente. Per mantenere la qualità della pelle evitare l'esposizione diretta alla luce del sole e alle fonti di calore, spolverare regolarmente la pelle con un panno morbido e asciutto. In caso di macchie, le stesse si possono eliminare usando un panno morbido inumidito con acqua e sapone neutro. Asciugare dopo il trattamento, non strofinare ma tamponare delicatamente. Non utilizzare assolutamente detergenti aggressivi o spray che possono danneggiare nel tempo l'aspetto e la tenuta della pelle.

Cleaning and maintenance – For the coated fabric maintenance, we suggest you to regularly vacuum clean. Stains can be cleaned with a soft damp cloth and mild soap; do not rub and allow to dry naturally. To maintain the beauty of the leather: avoid placing leather near direct sun or any heat sources, dust regularly with a soft and dry cloth. Spots can be washed off using a lightly damp cloth with mild soap; dry after the treatment, do not rub. Never use strong detergents or sprays that can damage the appearance and tightness of the leather over time.
